5) Vendor Fees:

All vendors are required to become members of the LCFM Society and pay a \$25.00 annual membership fee.

Full Season (20 dates) - \$574.50 (\$500.00 plus \$25.00 GST, plus \$24.50 for the HST effecting markets from July 7 onward, plus \$25.00 membership)

Full season fee is payable in two installments of \$287.25:

1st payment due on or before May 26, 2010, 2nd installment due on or before August 4, 2010.

Weekly fee \$30.00 plus g.s.t. = 31.50* payable on or before each date. (Note add membership fee to first date of the season).

Patio Table: \$20.00 plus g.s.t. = \$21.00* payable on or before each date (note: add membership fee to first date of the season)

Vehicle fee: \$10.00 plus g.s.t. = 10.50* per week (added to stall fees). Vehicle must be behind canopy, farmers only, limited number.

*Increases beginning July 7 to accommodate implementation of Harmonized Sales Tax

July 7 onwards rates are as follows:

Weekly fee \$30.00 plus H.S.T. = 33.60 payable on or before each date. (Note add membership fee to first date of the season).

Patio Table: \$20.00 plus H.S.T. = \$22.40 payable on or before each date (note: add membership fee to first date of the season)

Vehicle fee: \$10.00 plus H.S.T. = 11.20 per week (added to stall fees). Vehicle must be behind canopy, farmers only, limited number

Vendor notes:

1. Bring your own equipment for set up

2. Same space not guaranteed from week to week
3. Please leave pets at home
4. Leave stall space and surrounding area clean after each market

6) Cancellation Policy:

72 hours notice required for refund/credit. Please notify the manager by phone (778-245-0980) on market day if unexpectedly absent or late.

7) License Agreement:
